ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation is: 11420 CORP.

ARTICLE II

This corporation shall have perpetual existence.

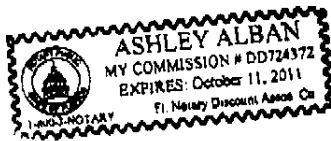
