**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
ACCELL GLOBAL RISK SOLUTIONS, INC.**

1. Name

The name of this Florida corporation is Accell Global Risk Solutions, Inc. (the "Corporation").

2. Amendment

Article IV of the Articles of Incorporation of the Corporation is hereby deleted and replaced in its entirety by the following:

Article IV

The Corporation shall have the authority to issue 10,000,000 shares of common stock.

3. Shareholder Approval

The amendment set forth in these Articles of Amendment was (a) unanimously approved by the Corporation's Board of Directors, (b) unanimously recommended by the Corporation's Board of Directors to its sole shareholder, and (c) unanimously approved by the Corporation's shareholders as of September 18, 2017. The number of votes cast for the approval and adoption of the amendment was sufficient for approval.
