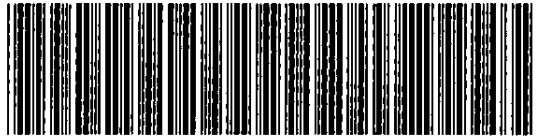

In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: EVERCLEAR CLEANING SOLUTIONS, INC.

**ARTICLE II**

The existence of the Corporation shall begin on the filing of these Articles of Incorporation.

**ARTICLE III**

The street address of the principal office of the Corporation is: 7512 Doctor Phillips Boulevard #50, Orlando, Florida 32819.

**ARTICLE IV**

The specific purpose for which the Corporation is organized is for all purposes lawful in the State of Florida.




