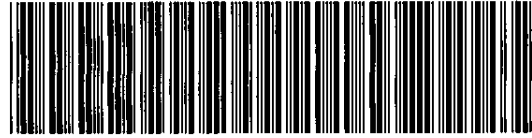

The name of this corporation is MARYSE OUELLET, INC.

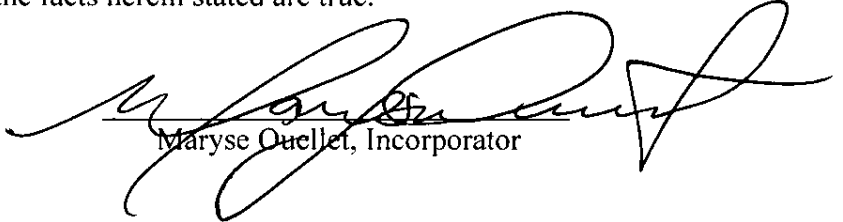

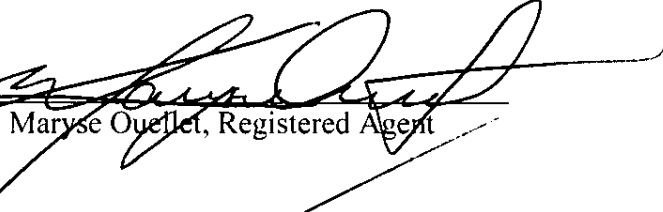
