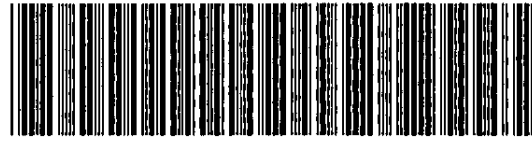

The name of the corporation shall be Small Molecule Technologies, Inc.

Each holder of shares of the Non-Voting Common Stock shall not be entitled to vote on any matter, except to the extent prohibited by the Florida Business Corporation Act.

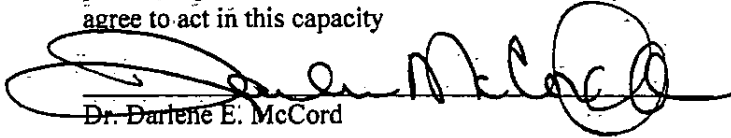

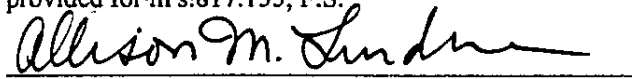
