OF

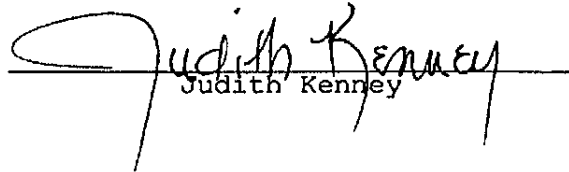

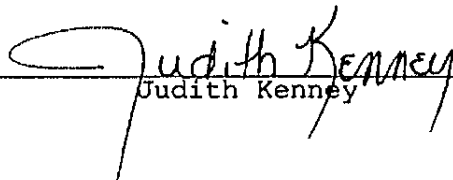
