As discussed in my telephone conversation with your office, the letter we received from the Florida Department of State, Division of Corporations dated May 20, 2004 (Letter Number: 104A00035123), erroneously indicated a total fee of \$18,000.00 to reinstate the above entity to do business in the State of Florida.

Subsequently, it was determined in my June 10, 2004 conversation with Tina Roberts of your office, that the actual total amount due for reinstatement of this entity was \$1,800.00, not the \$18,000.00 referred to in the letter. 
