**ARTICLES OF INCORPORATION  
OF  
CEDAR MOUNTAIN, CHARTERED**

ARTICLE I – NAME

The name of the corporation is Cedar Mountain, Chartered (the “Corporation”).

ARTICLE II – PRINCIPAL OFFICE

The principal place of business of the Corporation is 720 Cortaro Drive, Sun City Center, Florida, 33573. The mailing address of the Corporation is 10163 Celtic Ash Drive, Ruskin, FL 33573.

ARTICLE III – DURATION; PURPOSE

The period of duration for the Corporation shall be perpetual. The nature of the business to be conducted or promoted is to engage in the practice of physical therapy in accordance with the Physical Therapy Practice Act, F.S. Chapter 486. The purpose of the Corporation is any lawful act or activity for which a professional service corporation engaged in such profession may be organized under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and for which such corporation is permitted to engage in under other applicable law. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted and conferred on a corporation by the Professional Service Corporation and Limited Liability Company.

ARTICLE IV – CAPITAL STOCK

The total number of shares of capital stock that the Corporation has the authority to issue is one hundred (100) shares of common stock.
