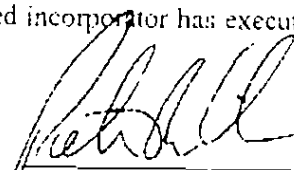
ARTICLE VII

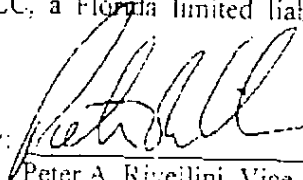
