OF

**ARTICLE I
Name**

The name of the corporation is **CLA Seller, Inc.** (the "Corporation").

All actions, including but not limited to, Amendment of Articles of Incorporation, required to be taken at any meeting may be taken by written consent as provided in Florida Statutes, as now amended or as same may be amended in the future.
