## ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF G4S COMPLIANCE & INVESTIGATIONS, INC.

Pursuant to the North Carolina Business Corporation Act (the "BCA"), G4S Compliance & Investigations, Inc., a North Carolina corporation (the "Corporation"), hereby submits the following Articles of Amendment to its Articles of Incorporation (the "Articles of Amendment"):
