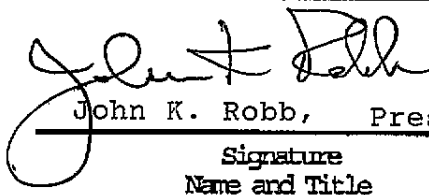

TO THE
ARTICLES OF INCORPORATION
OF
EXECUTONE/COASTAL, INC.

Pursuant to the provisions of the Code of Alabama (1975), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation heretofore filed in the Office of the Judge of Probate of Mobile County, Alabama, on the 14th day of June, 1991 in Real Property Book 3740, pages 159, et seq.:

FIRST: The present name of the corporation is EXECUTONE/COASTAL, INC.

SECOND: The following Amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on the 25 day of MAY, 2000, in the manner prescribed by the Alabama Business Corporations Act:

THE NAME OF THE CORPORATION SHALL BE CHANGED TO IDEACOM OF THE GULF COAST, INC..
