Effective December 31, 1998 at 5:00pm, Radonics, Inc. merged with and into its wholly owned subsidiary, U.S. Inspect, Inc.

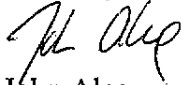

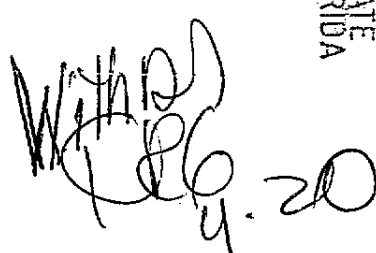
