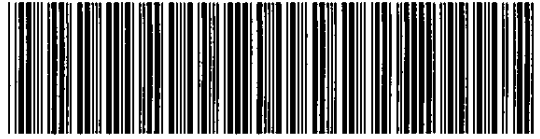




## NOTICE OF CORPORATE DISSOLUTION
