SECRETARY OF CHARACTER THE TANK OF THE TAN The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, heroby adopts the following Articles of Incorporation.

> ARTICLE I NAME

The name of the corporation shall be:

IBIS FINANCIAL SERVICES, INC.

ARTICLE II PRINCIPAL OFFICE

The mailing address of the initial principal office of this corporation is 7515 Pelican Bay Boulevard, Unit 18C, Naples, FL 33963. The Board of Directors may, from time to time, change the street and post office address of the principal office of the corporation.

ARTICLE III PURPOSE

To engage in any activity or business permitted under the laws of the United States and the State of Florida.
