The undersigned subscriber to these Articles of Incorporation of PARADISE FLOWERS AND GIFTS, INC., natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

FIRST: The name of the corporation is PARADISE FLOWERS AND GIFTS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

FOURTH: The aggregate number of shares that the corporation shall have authority to issue is 1000 shares of common stock with a par value of (\$ 0.10) per share.

FIFTH: The initial Board of Directors shall consist of two members initially: ROLANDO ZAYAS of 19522 S.W. 120 AV, Miami, Florida 33137 and ANA M. GUERRA of 19512 S.W. 120 AV, Miami, Florida 33137, who shall hold office for the first year of existence of this Corporation or until their successors are elected or appointed and have qualified, whichever occurs first. 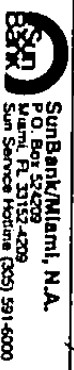


