**THIRD ARTICLES OF AMENDMENT TO  
THE ARTICLES OF INCORPORATION OF THE  
COMMUNITY BANK OF MANATEE**

Pursuant to Section 607.1002 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of Community Bank of Manatee (hereinafter, the "Bank") are amended in accordance with these Third Articles of Amendment:


**FIRST:** The name of the Bank is Community Bank of Manatee.

**SECOND:** Effective on the date hereof, Article III, Paragraph C, Section 1 of the Articles of Incorporation of the Bank is amended by deleting the phrase "100,000 shares" in the third line of Section 1 and by inserting the phrase "200,000 shares."


**THIRD:** All other provisions of the Articles of Incorporation shall remain in full force and effect.

**FOURTH:** The above Third Articles of Amendment were adopted by unanimous vote of the Board of Directors at a regular meeting on August 19, 2004. The Amendment was adopted by the Board without shareholder action and shareholder action was not required.
