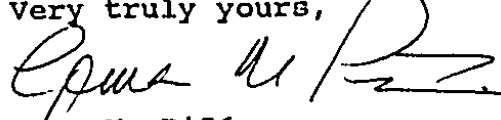

ARTICLES OF INCORPORATION

OF

F 2000 MINIMALISTA, INC.

A Florida Corporation

In compliance with the requirements of Chapter 607 of the Florida Statutes (the "Florida General Corporation Act"), the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

NAME

The name of the corporation (hereinafter called the "Corporation") is:

F 2000 Minimalista, Inc.

ARTICLE II

The initial principal place of business and address of the Corporation shall be:

1726 S.W. 2nd Avenue
Miami, Florida 33129

ARTICLE III

DURATION

The duration of the Corporation shall be perpetual.

ARTICLE IV

PURPOSE

The purposes of the Corporation, until such time as these Articles of Incorporation are amended pursuant to the provisions of the Florida General Corporation Act, shall be to

engage in any activities and business permitted under the laws of the United States and the State of Florida.

ARTICLE V

AUTHORIZED SHARES

The aggregate number of shares which the Corporation shall have the authority to issue is one thousand (1,000), all of which shall be Common Stock, each share having a par value of One Dollar (\$1.00). All shares of Common Stock shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters upon which stockholders have the right to vote.

ARTICLE VI

RESIDENT OFFICE AND AGENT

The initial post office address of the Corporation's initial registered office shall be 1726 S.W. 2nd Avenue, Miami, Florida 33129, and the initial registered agent for the Corporation at that address shall be Jesus Fuertes, whose business address is and will be identical with the registered office of the Corporation.

The number of directors constituting the initial Board of Directors of the Corporation shall be one.

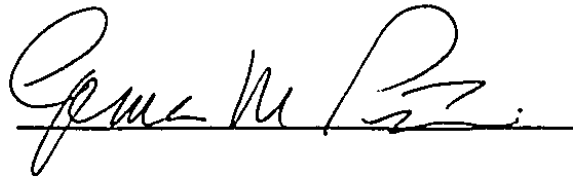
