

ARTICLES OF INCORPORATION

T & A CIGAR COMPANY, INC.

The undersigned Subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form(s) a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is T & A CIGAR COMPANY, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence and shall be effective upon filing of the Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

- A. To engaged in the business of wholesale and retail distribution of cigars and their related products, together with any and all ancillary and related matters thereto.
- B. To acquire by purchase, lease, or otherwise, lands and interests in lands, and to own, hold, improve, develop, and manage any real estate so acquired, and to erect or cause to be erected on any lands owned, held, or occupied by the corporation, buildings or other structures, public or private, with appurtenances. and to manage, operate, lease, rent, rebuild, enlarge, alter, or improve any buildings or other structures, now


