The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is TERRANCE J. MULLIN, P.A.

ARTICLE II

DURATION AND BEGINNING OF CORPORATE EXISTENCE

The corporation shall exist perpetually. The date when the corporate existence of this corporation shall begin shall be upon the date of filing of these Articles with the Secretary of State.

ARTICLE III

NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any and all lawful business. The specific nature of business is to render the same professional services to the public that an Attorney at Law, duly licensed under the laws of the State of Florida, is authorized to render.

ARTICLE IV

INDEMNIFICATION



This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto.



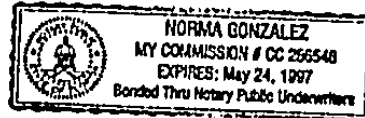


