The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida

ARTICLE I

Name and Address

Term of Existence

This corporation shall have perpetual existence, commencing with the date of incorporation.



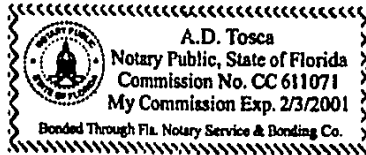
