ARTICLES OF INCORPORATION

Henry D. Paloci III, PA

Article 1. The name of this professional association shall be Henry D. Paloci III, PA, and the street address of the initial principal office of this professional association shall be 10265 N. Tamiami Trail, Suite 5, Naples, FL 34108.

Article 2. This professional association shall have perpetual existence.

Article 3. This professional association is organized for the purpose of the practice of law by attorneys duly approved by the Florida Bar.


Article 4. This professional association is authorized to issue five hundred (500) shares of \$1.00 par value common stock.
