**ARTICLES OF AMENDMENT
TO

Pursuant to the provisions of section 607.1006 Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation filed May 12, 1997, under Document No. P97000041966:

FIRST: Amendment(s) adopted: ARTICLE VIII - INTIAL DIRECTORS AND OFFICERS, whereas Sandra L. Wilson shall remain as Director and President of Affinity Marketing, Inc., and Gayle A. Lasater shall be removed as Secretary/Treasurer of said corporation. Sandra L. Wilson shall now be named as the Secretary/Treasurer of Affinity Marketing, Inc. thereby replacing Gayle A. Lasater in said position.

SECOND: If an amendment provides for an exchange reclassification or cancellation of issued shares, provisions for implementing the amendment if not contained in the amendment itself, are as follows: In accordance with the Articles of Incorporation, ARTICLE X - AMENDMENT, These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by at least majority of the stock entitled to vote thereon, unless all the directors and all the stockholders sign a written statement manifesting their intention that a certain amendment of the Articles be made.
