I am the accountant for the above named taxpayer who is in receipt of your Second Notice to file the 1998 Profit Corporation Annual Report.

Taxpayer is unwittingly involved in a situation for which the corporation should not be penalized. As the accountant, I made the necessary modifications to the annual report soon after the April 15 (individual income tax filing deadline) and submitted the report with a \$150 check.
