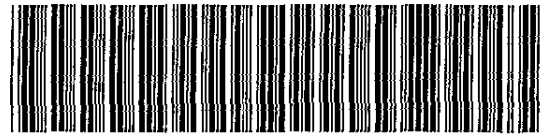


1. The name of the corporation is Fashion Handbags, Inc.com.
