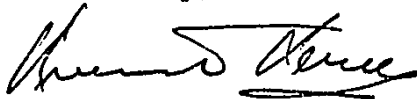

ARTICLE I. NAME

The name of this corporation is

5150, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 1998 and shall have perpetual existence.

ARTICLE III. PURPOSE

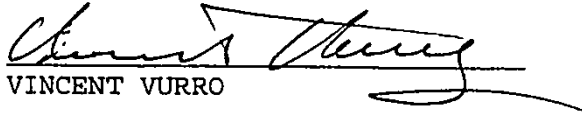

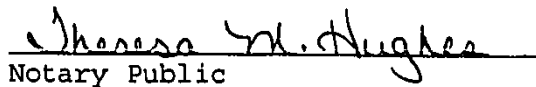

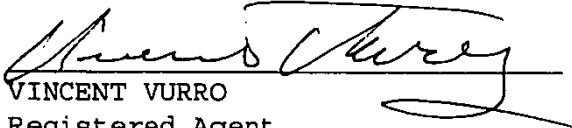
