The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be R-80 Rib City, Inc. The principal place of business of this corporation shall be 2122 Second Street, Fort Myers, FL 33901.

ARTICLE II. NATURE OF BUSINESS
