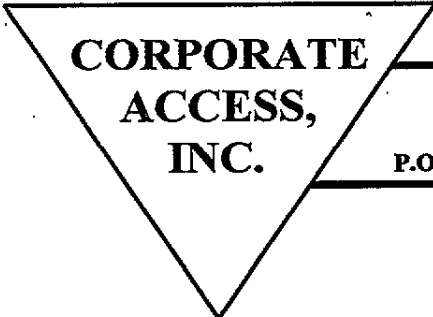

The Articles of Incorporation of **PRIDGEN INK, INC.**, a Florida corporation (the "Corporation") are hereby amended as follows:


1. The terms of Article I of the Articles of Incorporation are hereby deleted in their entirety and the following is substituted in lieu thereof:

IN WITNESS WHEREOF, the undersigned as President and Secretary of the Corporation have executed these Articles of Amendment this 15th day of October, 1999.



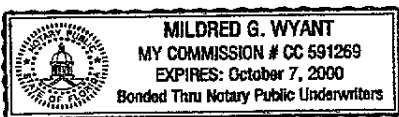
