ARTICLES OF INCORPORATION  
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, pursuant to Chapter 607 F.S., hereby adopts the following Articles of Incorporation.

ARTICLE I: Name

The name of the corporation shall be Functional Integrative Therapeutics & Technology, Inc.

The Corporation is a Corporation for profit and is organized for the purposes of engaging in any business allowed by law. In the best interest of the Corporation and its shareholders, the Corporation elects "S" Corporation status under the Internal Revenue Code of 1986 and the officers of the corporation are directed to obtain the consents of the shareholders of the corporation and properly file Internal Revenue Service Form 2553.

ARTICLE II: Principal Office

The principal place of business and mailing address shall be located in the State of Florida, County of Leon, City of Tallahassee at 3127 Ansley Park Drive, zip code 32308. The corporation may have such other offices, either within or without the State of Florida, as the business of the corporation may require from time to time.

ARTICLE III: Shares

1.0 The Corporation shall be authorized to issue its common stock in accordance with the provisions of #1244 of the Internal Revenue Code of 1954, as amended, pursuant to such prior plans as it may from time to time adopt, and the Board of Directors of the Corporation shall be authorized to adopt the initial plan of issuance of such common stock at its first organizational meeting;

2.0 The maximum number of shares of capital stock that the Corporation shall be authorized to have outstanding at any time shall be 1,000,000 shares of common stock, no par value;

3.0 Non of the holders of shares of common stock of the Corporation shall be entitled as a matter of right to purchase, subscribe for or acquire any new or additional shares of capital stock of the Corporation of any class, or any options or warrants; and

4.0 The Board of Directors of the Corporation may authorize the issuance of bonds, debentures and

other evidences of indebtedness of the Corporation and may fix all the terms thereof, including, without limitation, the convertibility thereof into shares of stock of the Corporation of any class, or any series of the same class.

**ARTICLE IV: Initial Registered Agent and Street Address**

The initial registered office of the Corporation shall be 3127 Ansley Park Drive, Tallahassee, Florida, 32308, and the initial registered agent of the Corporation at such address shall be Jay Matteson citizens of the United States of America.
