ARTICLES OF INCORPORATION
OF

The undersigned subscriber to those Articles of Incorporation, is a natural person competent to contract, and to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is Star Marble USA, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

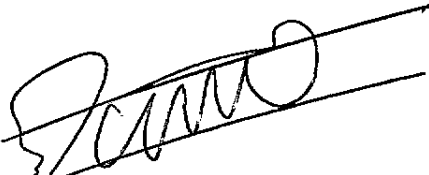

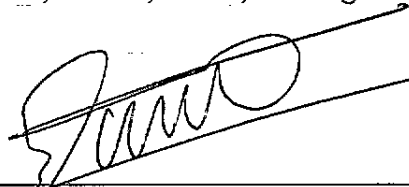
