

**ARTICLE I. NAME**

The name of this corporation shall be In-House Counsel Healthcare, P.A.

**ARTICLE II. COMMENCEMENT & DURATION**

The address of this corporation's initial registered office shall be: 11242 S.W. 128 Place, Miami, Florida 33186.




