WE, THE UNDERSIGNED, all of the age of eighteen years or over, for the purpose of forming a corporation pursuant to Section 607.0401 of the statutes of the State of Florida, do hereby certify:

FIRST: The name of the corporation is:

T-28 Corporation

The purposes for which it is formed are:

To engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida provided that the corporation is not formed to engage in any act or activity which requires the consent or approval of any state official, department, board, agency or other body, without such consent or approval first being obtained.

THIRD: The Corporation is authorized to issue a single class of shares, the total number of shares authorized is 1,000, no par value.


