# ARTICLES OF INCORPORATION OF 822 PIZZA CORP.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

#### ARTICLE I. NAME

The name of the corporation shall be 822 PIZZA CORP.

The principal address of the corporation at the time of incorporation is 822 S. Federal Highway, Pompano Beach, Florida 33082.

#### ARTICLE II. DURATION

The duration of this corporation is perpetual, unless dissolved according to law.
