The name of the Corporation is **ADVANCED LEARNING CENTERS, INC.**

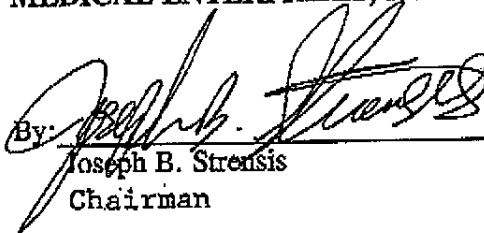
