SECOND: The Articles of Incorporation were filed on June 8, 1999.

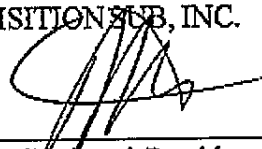
THIRD: None of the Corporation's shares have been issued.
