

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I.**

The name of this corporation is A-1 SEPTIC TANK SERVICE, INC.

**ARTICLE II.**

The main location where the company shall conduct its business is 8300 West Beaver Street, Jacksonville, Florida 32220.

**ARTICLE III.**

The duration of the corporation shall be perpetual.

**ARTICLE IV.**

The purpose of the corporation shall be the maintenance and repair of all septic tank systems and for any other lawful purpose for which corporations for profit are incorporated under the laws of the State of Florida.

The aggregate number of shares which the corporation shall have authority to issue is One Hundred (100) shares of common stock with a par value of Five Dollars (\$5.00) per share.


**ARTICLE VII.**


