ARTICLES OF INCORPORATION OF SACRED THREADS, INC.

Article 1

Name. The name of this Corporation is SACRED THREADS, INC.

Article II

<u>Principal Office</u>: The principal place of business and mailing address of this corporation shall be: 6527 N.W. 18TH Drive Gainesville, Florida, 32653.

Article III

<u>Duration</u>. The period of duration of this Corporation shall be perpetual.

Article IV
