To whom it may concern:

This letter is in response to my telephone conversation with your office, today, Dec. 11th 2001. I was very much shocked to here that my corporation, **Eagle View Entertainment, Inc.**, was “dissolved”, on Sept. 2001.

Enclosed, you will find a check in the amount of \$ 150.00 and the following is a detailed account of the entire situation.

Early this year, I moved to a new location and I had my mail forwarded to my new address. My accountant was supposed to notify all government offices, concerning the corporation, with my new address. Later in the year, in May, I then opened up an office in Los Angeles, California.

My fiscal year ends on Dec.31, 2001; and for the past two months I have been trying to contact my accountant only to find out that she is no longer in business. This obviously took me by surprise and I began questioning her work since she was taking care of the corporation and paying any necessary fees. I then started backtracking to make sure that all important documents were taken care of and fees were paid. I also placed a call to your office to make sure that all is in order. After my call today, I was convinced that that was not the case; and I was absolutely stunned to here that my corporation was “dissolved” and that you’ve allegedly sent two or tree correspondence letters that never reached me and have been, subsequently, returned to you.

Not only was my mail not forwarded by the post office, but also my accountant put me in this bad situation by not notifying me about closing her business and what had not been handled yet.

I would like to apologize for any inconvenience that has caused your department and I request a-reinstatement of my corporation. Moreover, after you have read this account, I hope that any penalties can be waived due to the fact that I had not be made aware of the above circumstances until now.
