



1) The name of the corporation is NATIONAL STAR, INC., Corporate document number S87710.

2) The following amendments of the articles of incorporation were adopted by the shareholders and directors of the corporation on 3/28/06 in the manner prescribed by the Florida Business Corporation Act:

4) The designation and number of outstanding shares of each class entitled to vote on the amendments as a class were as follows:






